Subject: 2003 MALPRACTICE PREMIUM REIMBURSEMENT PROGRAM – OPTION C

Physicians are reminded that their application for Reimbursement of Malpractice Fees for the year 2003, (Option C only), must be **received** by the Ministry of Health and Long-Term Care no later than **June 30, 2004**.

You must return the completed application and your 2003 Canadian Medical Protective Association (CMPA) Acknowledgement to the Ministry of Health and Long-Term Care.

If covered by an insurer other than the CMPA, a receipt demonstrating proof of payment for the year 2003 must be enclosed.
